Competition Terms and Conditions**

1. Information on how to enter the Competition forms part of these Terms and Conditions.
2. Entry into the Competition shall be deemed acceptance of these Terms and Conditions. Entries not made in accordance with these Terms and Conditions will be disqualified.
3. The Competition commences at 09:00am on 11 September 2020 Australian Central Standard Time (ACST) and closes at 11.00pm on 16 October 2020 Australian Central Daylight Savings Time (ACDST) (“Promotion Period”).
4. The Promoter is Beyond Bank Australia Ltd, 100 Waymouth Street, Adelaide, SA 5000 (ABN 15 087 651 143, AFSL / Australian Credit Licence 237856) (“Promoter”).
5. Entry into this Competition is open to residents of New South Wales aged 18 years and over.
